<p>4. Once Allied World issues the work authorization, the windscreen repairers will notify the vehicle owner; 待 世聯 發出「開工紙」後，維修商會通知車主；</p>											
<p>5. The vehicle owner may drive directly to the windscreen repairers for windscreen repair or replacement; 車主可直接駕車前往該維修商進行維修；</p>											
<p>6. The vehicle owner is required to sign the claim form. During the process, the owner can enjoy cashless service, with no advance payment or claim follow-up required. 維修商將要求車主簽署索償表格。期間，車主無需支付任何費用，亦無需跟進索償事宜。</p>											

<p>Remarks 備註：</p> <ul style="list-style-type: none"> For isolated damage to the vehicle's windscreen, the Insurer will cover the repair or replacement costs and waive any policy excess if the repair cost does not exceed HK\$5,000, provided the work is done by the Insurer's designated windscreen repairers: 就汽車擋風玻璃損壞，若維修費不超過港幣 5,000 元，世聯將支付維修或更換費用，並豁免保單自付額，但須由指定擋風玻璃維修商進行。 If the vehicle windscreen repair or replacement is done by the designated windscreen repairers, the NCD will remain unaffected. 如使用指定擋風玻璃維修商進行維修，無索償折扣 (NCD) 不受影響。 The vehicle owner may alternatively opt for OEM windscreen repair or replacement service, but reimbursement may be partial, the excess is payable by the vehicle owner, and the NCD will be reduced. 車主亦可選擇於原廠維修並使用原廠玻璃，惟賠償可能不足額，自付額須由車主承擔，且無索償折扣 (NCD) 將被扣減。 For inquiries, please contact us (Tel: 3153 4003). 如有疑問，請致電本公司查詢 (電話：3153 4003)。
